Mission Statement

The Mystic Krewe is a social/charitable organization of select individuals of high standing, talent, principal and generosity that have assembled for the purpose of enjoying each others' company and working collectively on projects for amusement as well as for the benefit and elevation of mankind.

In consideration of and in accordance with the foregoing mission statement, the undersigned Member hereby agrees to the following terms and conditions:

- 1. <u>Term</u> This agreement is effective as of the first day of the month following the signature date and automatically renews every month thereafter so long as membership dues are paid in accordance with this agreement or until terminated in accordance with this Agreement.
- 2. <u>Membership Dues</u> The Member must pay dues in full prior to the first day of the month covered by those dues. The undersigned Member has agreed to pay ______ dues as membership dues. Members must pay dues via an automatic, recurring payment system such as

- Paypal unless approved by Manager.
- 3. <u>Termination</u> Member may terminate this agreement at any time. Upon termination, any prepaid membership dues are forfeited.

The Club may terminate this agreement at any time for any reason. Decisions to terminate are made in the sole discretion of Michael Perry, as Owner and Manager of the Club ("Manager"). Upon termination, dues for the remainder of the month of termination are forfeited. Any other dues paid in advance will be returned to Member.

4. <u>The Collection</u> - The "Collection" is set of resource(s) that are operated by the Manager. Club members may have access to the collection, but the collection itself is an autonomous, private venue.

5. Access –

- A. Members may access Collection, generally on a certain schedule (i.e. at least one day a week), with permission of the Manager, which permission will not be unreasonably withheld.
- B. No non-members will be allowed to visit the collection without prior approval from the Manager. Member may bring guests to visit Collection with prior permission from Manager. In exceptional circumstances Managers may allow guests under the age of 16. Manager may request that frequent guests become Members.
- C. All members and guests must sign in and out of any Club function.
- D. Member is responsible, financial and otherwise, for any damage that he causes, or that his guests cause, to any part of the Collection or to the private property at which the Collection is located. "Damage" is anything beyond normal wear and tear as determined in the sole discretion of the Manager.
- E. Member indemnifies the Club and the Manager for any injury to any person resulting from the actions of that Member or that Member's guest.
- F. Manager may deny access to Collection to anyone at any time. Access may be denied on an ongoing basis.

6. Other Terms -

A. **Non-Disparagement**. During the Membership Term and thereafterj, Member agrees to take no action which is intended, or would reasonably be expected, to harm the Club or its or their reputation or which would reasonably be expected to lead to unwanted or unfavorable publicity to the Club or any of its members.

- B. **Severability**. The invalidity or unenforceability of any provisions of this Agreement shall not affect the validity or enforceability of any other provision of this Agreement, which shall remain in full force and effect.
- C. Participation in Club activities. Member agrees to assist on a regular basis during various Club functions, including but not limited to helping host tournaments, open houses, meetings, manage and maintain resources, assist with group efforts such as fundraising, keep the Collection clean and in good working order and help other members when needed where time and ability allow.
- D. **Jurisdiction.** This Agreement shall be governed by and construed in accordance with the laws of the State of Louisiana, without regard to its conflict of laws rules.
- 7. <u>Code of Conduct</u> Member agrees to adhere to the Club's "Code of Conduct" See attachment "Code of Conduct." Failure to comply with the "Code of Conduct" may result in removal from Club.
- 8. MK members are an exclusive group, committed to helping each other and their community. As such it's important to show respect for all members and their resources. Our motto of "Better Than Before" (BTB) should be reflected in our attention to detail and desire to improve ourselves, the resources at our disposal and everything else around us.
